Comments: AS NOTED ABOVE, THE STATION AIRED 576 PSAS DURING FOURTH QUARTER. THE STATION'S HARDWARE USED TO GENERATE CSTS FAILED; THEREFORE, NO CSTS WERE AIRED DURING FOURTH QUARTER. HOWEVER, THE STATION MORE THAN COMPENSATED BY AIRING 2.75 TIMES OF THE REQUIRED NUMBER OF PSAS. ON DECEMBER 10, 2009, THE COMMISSION GRANTED THE STATION'S MODIFIED CONSTRUCTION PERMIT (FCC FILE NO. BMPCDT-20091009AAR) WHICH RECOGNIZED THE STATION'S ALREADY CONSTRUCTED AND OPERATING FACILITY AS THE STATION'S FULL POST-TRANSITION FACILITY, WHICH HAD BEEN OPERATING SINCE PRIOR TO JUNE 12, 2009.
