Synopsis: Possible trespass and vandalism by hunters on private property.

Narrative: On 10-13-2007, at 1138 Hrs, I was dispatched to a trespass at [REDACTED]. The reportee (V) Delbert Knee stated there were two hunters on his property and he has their vehicle locked inside his gate. While enroute the call, dispatch advised there was a supplement to the call I needed to check on my MDC. The supplement information stated one of the hunters, who was being blocked in by the homeowner, was

calling in identifying himself as the chief of police for Pacific PD. The update stated that he had permission to be on the property by way of the easement, which crosses the original callers property and the original caller was accusing them of trespassing. He told dispatch they have put their weapons inside is orange and white GMC truck and are waiting for us to arrive. It appears they also received a call from a [REDACTED]

While enroute the call, I called Delbert Knee on the phone to see what was going on. Delbert said he found a truck parked on his property this morning that he didn't recognize, so he called his uncle [REDACTED] who owns the property to see if he knows anything about the truck. He said [REDACTED] didn't know who the truck belonged to and he hadn't granted anyone permission to enter the property, so he told Delbert to lock the gate. [REDACTED] Delbert said he saw the hunters walk up to the truck a while later, so he waited for them to pull up to his locked gate to confront them and let them know they were trespassing on his property. He said the passenger of the truck got out and flashed a badge in his face and told him he better unlock the gate or he would have him arrested. Delbert said the subjects were still there in their truck and he will wait for me to arrive.

I arrived in the area at approximately 1200 Hrs. but the address in question is difficult to locate and I initially drove past the access road. Delbert's wife [REDACTED], who didn't witness the event) saw me drive by and flagged me down a few blocks down the road. I arrived at the residence at 1206 Hrs (approximately 3/10th's of a mile off the main paved road) and I learned the subjects had left in the listed truck after they pulled the gate post from the ground to open the locked gate.

Upon arrival, Delbert Knee reiterated what he told me on the phone regarding the hunters in the listed truck trespassing on the property. He said he is renting the property from his uncle [REDACTED] and has control over the property. Delbert said the incident began at approximately 0930 Hrs this morning, when he discovered the listed truck parked on his property. He said he called Gary Kiehl about the truck and Gary told him to lock the red steel gate out front (it had been standing open) until they come out and let them know they are trespassing. Delbert said he locked the gate and at approximately 1045 Hrs, he saw two hunters with rifles walk back to the truck. He decided to wait for them to drive down to the red gate before he confronted them. He said he walked up to the truck as they pulled up to the gate and told them they were trespassing on his property. Delbert said the passenger, whom he described as an older W/M, 5-09 tall, 200 with gray hair, who spoke through a tracheotomy hole in his throat, jumped out of the truck and approached him in an aggressive manner. He said the subject told him he better open the fucking gate and that they had permission from [REDACTED] to hunt on his property. Delbert said the subject removed a wallet from his pocket and flashed some kind of badge in his face and told him he would have him arrested if he didn't open the gate. He said the subject was so quick with the badge that he couldn't see what department it was from before the subject put the wallet back in his pocket. Delbert said he asked the subject for his name and the subject told him it was none of his fucking business and he doesn't have to tell him his name.

Delbert said he stepped away from the truck and called [REDACTED] again to see what he wanted him to do. He said [REDACTED] told him to call the police.

While waiting for me to arrive, Delbert said the subjects eventually left in the truck through the gate. He said he couldn't see how they got the gate open so he walked out to look and found they pulled the gate post out of the ground. The gate post was still chained to the gate when it was opened. Delbert said the time frame was approximately 20 minutes from when he contacted the subjects in the truck to when they pulled the post out of the ground and left. He said the driver of the truck, whom he described as a W/M, 23-24 YOA, 5-08 tall 200 with brown hair never got out of the truck or said anything during the incident. See the attached handwritten statement by Delbert for more details.

Delbert's step children were in the residence and they witnessed part of the incident. I spoke to (W) [REDACTED] first. [REDACTED] said he saw the W/M in his 50's with an orange hat get out of the truck and he got up in Delbert's face as he pointed at Delbert. He said from inside their house he could hear the man raising his voice but couldn't tell what was being said. [REDACTED] said he saw the man display what looked like a badge at Delbert. He said the last he saw of the man, he was walking toward the locked gate and then the truck was driven away. He couldn't see how the gate was opened. See the attached handwritten statement by [REDACTED] for more details.

I spoke to [REDACTED]s sister [REDACTED], who saw the older W/M get out of the truck and approach her step father Delbert. She said he was up in Delbert's face and it looked like he was yelling at Delbert, but

from inside the house she couldn't hear what was being said. [REDACTED] said she saw the man talk on his phone for a while and the last she saw of him is when he walked over to the gate before the truck drove away. See the attached handwritten statement by [REDACTED] for more details.

I used my department issued digital camera to photograph the gate and post along with the other gates up the driveway. The area is clearly posted no trespassing. I saw the metal gate up the driveway was also locked and I asked Delbert how the subjects were able to get past that gate, as he indicated they were initially parked inside this gate. Delbert said that [REDACTED] leaves a key on the post to that gate for people to enter so the subjects must have used the key.

After I cleared the scene, I reviewed the information in the call on my MDC and discovered additional information that was added two minutes prior to my arrival at the residence with [REDACTED]. The supplement information states they received a call from one of the hunter's John Calkins (also the registered owner of the listed truck) who said he pulled the gate up and left and they are in the orange and white truck. He also states that he will pursue unlawful imprisonment charges on Monday. I notified the eastside supervisor Sgt. Pebbly #61 of the situation.

At 1315 Hrs, I attempted to call John Calkins on the cell phone number he left with dispatch (253-335 2682) and I left a voicemail for him to call me about the incident.

At 1501 Hrs, I received a message from dispatch indicating that John Calkins had returned my call and he was waiting for a call back at 253-261-9594. I attempted to call him back at this number, but the call went to voicemail again. I left a second message with my cell phone number for him to call.

At 1503 Hrs, John Calkins called my cell phone and I spoke to him about the trespass call. I confirmed with John that he is the chief of police for Pacific Police Department. John said he wasn't trespassing on the property and that he had permission from [REDACTED] to hunt on the property. I explained to John that he may have had permission to be on [REDACTED] vacant wooded property, but it doesn't appear that he had permission to be on Delbert Knee's property which is the road leading up to [REDACTED] property. I told him he needs to be sure to person giving him permission to be on other property has the authority to give that permission. John said it wasn't criminal on his end because he had no knowledge. I asked John about flashing his badge at the homeowner, his refusal to tell the homeowner who he is (name, department he works for ETC), and telling the homeowner he would have him arrested if he didn't open the gate. John admitted to doing all these things. I asked John if he pulled the gate post out of the ground and he said yes. I asked John why he didn't wait for us to arrive. He said he called dispatch twice about the incident. John said during the first call, the dispatcher told him nobody was even enroute and on the second call, they refused to give him our ETA. He said he it wasn't an emergency, but he had a family event to go to so he "Muscled" the gate post out of the ground and they left. John said he didn't see any patrol vehicles on his way out so it is likely he drove out after I went past the entry road. He said he didn't damage anything when he pulled the post out. John identified the other hunter with him as his son [REDACTED]. I asked John about entry to the second gate and he said he used a key to unlock the gate. I asked him if he used the key left on the post and he said no, that he used a key given to him by [REDACTED].

I told John this report would be forwarded to the Prosecutor's office for review/ charging consideration of criminal trespass and vandalism. John said he intends to file an unlawful imprisonment report on Monday for the homeowner locking them inside the gate and refusing to unlock it. I told John that information is included in this report and gave him the case #.

At this time, I do not have a phone number to contact [REDACTED]

On 10-14-2007, at 0745 Hrs, I called [REDACTED] on the phone regarding the trespass. [REDACTED] said he has an unfriendly history with [REDACTED] over access to [REDACTED] property. He said he has only seen [REDACTED] 3 times in his life and only the first was pleasant, when he allowed [REDACTED] to use an access road through his property to log his wooded lot. [REDACTED] said [REDACTED] later tried to develop his property and during their second contact, he requested an easement road through his [REDACTED] property for the development. He said he refused to allow the easement road which later led to the third contact with [REDACTED] who called him every name in the book. [REDACTED] said he doesn't have a problem with [REDACTED] accessing his own property but this access is not for [REDACTED] friends and relatives to use for their recreation. He said hunters especially are required beforehand to get written permission to hunt on private property and neither he nor Delbert was asked

permission by anyone to enter his property. I gave [REDACTED] the case # for this report and he said he intends to contact the game department regarding the trespass.

I placed the listed photos I took of the scene on to a CD-R disc as a back up disc before uploading the photos to the server. I placed the CD containing the photos into property at the Foothills Detachment Office as evidence. Nothing further


